



Terms and Conditions

Liability Waiver

In consideration of the acceptance of my or my child's application, as a participant in the North County Classical Ballet, LLC (NCCB) Program or related activities I hereby agree to assume all risks attendant upon myself and/or my child while participating in the NCCB Program. I hereby waive, release, and discharge any and all claims for damages for death, personal injury or property damage which I or my child may have, or which may hereafter accrue to me or my child, as a result of my or my child's participation in the NCCB Summer Intensive Program. I agree to save and hold harmless from liability the NCCB, and/or any of their agents, servants, contractors, volunteers, or employees by reason of any accident, death, injury or damages to persons or property which I or my child may suffer, from and against any and all liability arising out of or connected in any way with my or my child's participation in the NCCB Program, even though that liability may arise out of negligence or carelessness on the part of the persons or entities mentioned above.

I further understand that serious accidents can occur during ballet and dance activities and that participants in dance and ballet activities occasionally sustain mortal or serious personal injuries, and/or property damage as a consequence thereof. Knowing the risk of dance and ballet activities, nevertheless, I hereby agree to assume on my behalf and on behalf of my child those risks and to release and hold harmless all of the persons mentioned above who (through negligence or carelessness) might otherwise be liable to me or my child (or my heirs or assigns, or my child's heirs or assigns) for damages.

It is further understood and agreed that this waiver, release and assumption of risks is to be binding on my heirs and assigns, and the heirs and assigns of my child. I agree to assume all responsibility for any property damage or injury caused by me or my child while participating in the NCCB Program.

Fitness

You or your child must be physically fit to participate in this program.

Holidays and Studio Closure

The studio will be closed on Christmas Day, New Year's Day, Thanksgiving Day, Labor Day, and possibly on other days. Students will be notified of studio closure days.

Model Release

I understand that during the NCCB Program or related activities, my photograph and/or photograph of my child may be taken by the NCCB, its producers, sponsors, organizers and/or assigns. I agree that my photograph and/or the photograph of my child, including video photography, film photography, or other reproduction of my likeness or the likeness of my child, may be used without charge by the NCCB, its producers, sponsors, organizers and/or assigns for educational, and/or other necessary legal purposes.

Authorization to Treat a Minor

I, the parent or legal guardian of the child listed, do hereby authorize and consent to any X-ray examination, anesthetic, medical, or surgical treatment rendered under the general or special supervision of any member of the medical staff and emergency room staff licensed under the provisions of the Medical Practice Act or a Dentist licensed under the provisions of the Dental Practice Act and on the staff of any acute general hospital or emergency care facility holding a current license to operate a hospital or emergency care facility from the State of California Department of Public Health. I understand that this authorization is given in advance of any specific diagnosis, treatment of hospital care being required, but is given to provide authority and power to render care which the aforementioned physician, in the exercise of his/her best judgment, may deem advisable for my child. Further, I agree to pay for my child's medical expenses. I understand that all effort shall be made to contact me prior to rendering treatment to my child, but any of the above treatment will not be withheld if I cannot be reached. This authorization is given pursuant to the provisions of the California Civil Code. This consent shall remain in effect until the end of my child's participation in the NCCB Program.

Tuition Fees and Refund Policy

Students enrolled in pre-ballet/academy level pay monthly tuition determined by the number of weekly classes. Tuition is due on the 1st day of each month. A 5% late fee will be charged if tuition is not paid by the 5th of the month. Tuition is billed monthly on the 20th of each month. Tuition payment is accepted by cash, check, credit card or online. You may also select monthly auto-pay for tuition payments (credit card payments only).

There is no refund for students suspended or removed for disciplinary reasons.

NCCB reserves the right to cancel classes, and will issue a full refund in this case. Enrollment is subject to availability, and is at the discretion of the studio.

Drop-Off and Pick-Up

NCCB is not responsible for children's safety outside of class time. Please be prompt when picking up and dropping off your child.

Dress Code

Participants must wear appropriate ballet dress.

- **Girls:** leotard (see below), pink-footed tights and pink ballet shoes with elastic sewn on. Hair to be in a neat bun, all bangs away from face. Level 7 or higher may wear a matching skirt.
- **Boys:** black tights, jazz pants or shorts, black ballet shoes and a white shirt.
- **Adults:** comfortable workout clothes. Hair pulled back from face.

Students who do not meet this dress code may be asked to fix their appearance before joining the class.

Students should put ballet shoes on inside the studio and take them off before leaving. Wearing ballet shoes outside brings dirt onto the ballet floor, and causes faster wear.

Levels

New students will be evaluated during their first class and placed in the appropriate level. For students placed in a level with younger children, the instructor can recommend how to build the technique required for advancement.

Academy levels go from Level 1 up to Level 10. The curriculum is based on the Vaganova method. Students will be evaluated at the end of the academic year; advancement decisions are at the discretion of the directors.

Pointe class is taught separately and starts at Level 3.

Pre-ballet is a preparation for academy classes. Students age 3 to 6 may enroll in the pre-academy classes.

Ballet conditioning is open to Level 1 and up. Training focuses on the flexibility and strength needed for ballet.

Performance and Competition

Stage productions are offered twice yearly and are subject to a performance agreement. A performance fee is required for each student in a production. Every student who auditions will be offered a part.

There may be additional performance and learning opportunities available. Ask your instructor if you are interested in private classes, choreography, or preparation for ballet competitions. We recommend a minimum of two classes per week for Pre-Ballet through Level 2, and three classes per week for Level 3 and up.

Studio Etiquette

No street shoes are allowed on the ballet floor. Please do not cross the dance floor during class. The studio provides a bathroom that can be accessed via the back door.

Ballet is a gracious and non-verbal art therefore there will be no talking in class as a sign of respect to both the instructors and the fellow dancers.

Late Arrivals and Absences

Students should arrive properly attired and on time. After class starts, a student should wait until the music stops and the instructor signals that they may join the class. Due to risk of injury, students who arrive more than 15 minutes late may be required observe the class.

If you cannot attend a scheduled class, please advise the studio in advance by phone or email. Students may make up missed classes or classes cancelled because of holidays or studio closure in any class at their level or below within 30 days. Please let your instructor know that you are attending a make-up class. Missed classes cannot be refunded, transferred or applied to future tuition.

Cell phones and Other Distractions

It is important to remain focused on ballet activities. Students must turn off and put away cell phones, and other personal electronics while at the studio or at a theatre.

Photos and video should not be taken during class, performances, or in the dressing rooms. NCCB is not responsible for lost, stolen or broken items. Please respect the instructors and dancers by keeping the studio curtain closed during class.

Parent and Student Behavior

Parents may observe their student's first class and open classes held twice a year. Parents or relatives may observe the class on special occasions with instructor's permission. Otherwise we ask that only the students and instructors be in the studio during classes so that there are no distractions.

Students and parents are expected to treat instructors, staff, other students and parents as well as personal and studio property with respect and courtesy.

Parents should not interrupt class or rehearsals. Foul language is prohibited. Older student and adults are expected to set a good example for younger students.

Repeated misconduct will affect a student's promotion and participation in NCCB productions. Students who regularly violate NCCB policies may be dismissed from NCCB.
